

| 14 | Running of coaching institutions in the school premises in the pretext of providing coaching to the students for various examinations is not permitted by the Board. Strict action would be taken on defaulters. |
| 15 | The school shall submit their information through Online Affiliated School Information System (OASIS) annually and keep the information updated throughout the year as per details given in circular no. affiliation-06/2018 dated 24.04.2018. Link for OASIS is available on Board's website: www.cbse.nic.in. |
| 16 | The school is required to contact the concerned Regional Office of CBSE for allotment of school number and password for online Registration of candidates. |
